

Agreement Addendum for Reciprocal Agreement for Licensing of Nonresident Agents/Producers of Florida Department of Financial Services and the Office of the Commissioner of Insurance of Puerto Rico

This Addendum is entered into by the State of Florida, Department of Financial Services (hereinafter referred to as "DEPARTMENT"), and the Commonwealth of Puerto Rico, Office of the Commissioner of Insurance (hereinafter referred to as "OFFICE").

WHEREAS, the DEPARTMENT and OFFICE have an existing agreement, *Reciprocal Agreement for Licensing of Nonresident Agents/Producers Florida Department of Financial Services and the Office of the Commissioner of Insurance of Puerto Rico* (hereinafter the "AGREEMENT"); and

WHEREAS, it is deemed desirable to add to the current AGREEMENT for the licensing of non-resident adjusters;

NOW THEREFORE, pursuant to the terms of the AGREEMENT, the undersigned officers agree, and do hereby bind their respective States or Commonwealth to the following addendum to the AGREEMENT:

1. That the Commonwealth will license the residents of Florida as both a nonresident Automobile and accident adjuster; and as a non resident Marine, transportation, fire and allied lines adjuster, as not to exceed the authority granted in an applicant's resident state for the authority applied for as a non-resident.
2. That the State of Florida will license the residents of the Commonwealth as a nonresident All Lines Adjuster if licensed by the Commonwealth as having both an Automobile and accident adjuster; and as a non resident Marine, transportation, fire and allied lines adjuster, as not to exceed the authority granted in an applicant's resident state for the authority applied for as a non-resident.
3. This addendum shall be effective upon the execution of the same by both parties.
