## PUBLIC NOTICE

### PETITION FOR ADJUSTMENT OF TARIFF CASE NUM. TA – 4067 THE PIPELINE OF PUERTO RICO, INC.

**APPROVAL FOR THE ADJUSTMENT TO THE TARIFF APPLICABLE TO THE PIPELINES OF PUERTO RICO, INC, FOR THE OPERATION OF THE UNDERGROUND PIPELINE FOR THE TRANSPORT OF JET FUEL FROM THE PORT FACILITIES IN GUAYNABO TO THE LUIS MUÑOZ MARIN INTERNATIONAL AIRPORT.**

In accordance with Law 109 of June 28, 1962, as amended, known as the "Puerto Rico Public Service Act" and Law 170 of August 12, 1988, as amended, known as the "Uniform Administrative Procedure Act", notice is hereby given that the Public Service Commission is considering a petition for an adjustment of the tariff applicable to The Pipelines of Puerto Rico, Inc., for the operation of the underground pipeline dedicated exclusively to the transport of jet fuel from the port facilities in Guaynabo to the storage and distribution facilities operated by British Petroleum of Puerto Rico, Inc. and Total Petroleum Puerto Rico Corp. lessees of the Puerto Rico Ports Authority, at the Luis Muñoz Marín International Airport.

The Pipelines de Puerto Rico. Inc. has requested the adjustment of the current tariff of \$0.245 cents per barrel of fuel transported approved on November 15, 1985. The Petitioner sustains that this request is necessary due to the increases in the costs of operation during the past two decades. Pipelines alleges that the current tariff does not allow for the generation of sufficient income to cover the expenses related to the maintenance, safety, monitoring, regulatory compliance, payroll and cost of capital investment that the operation of the service requires. An adjustment of the tariff up to \$0.809 cents per barrel (42 gallons or 158.94 liters) transported is requested, which amount is based on the economic analysis presented by the petitioner. This represents a \$0.564 increase.

With the purpose of allowing all interested persons an opportunity to comment on the petition, the public in general is invited to participate in a public hearing to be held on **June 21, 2010, at 8:30a.m., in Public Hearing Room A** of the Commissions Main Office, located at Muñoz Rivera Ave. #50 in Hato Rey, Puerto Rico.
