**ADOPTION OF A NEW REGULATION
RELATED TO AMBULANCE SERVICES
IN PUERTO RICO**

PUBLIC HEARINGS NOTICE

In accordance with 1962 P.R. Law 109, as amended, known as "Puerto Rico Public Service Act" and the 1974 P.R. Law 225 of July 23, as amended, known as "Ambulance Service Act" and 1988 P. R. Law 170, as amended, known as "Uniform Administrative Procedures Act" the Public Service Commission proposes the adoption a new Regulation related to Ambulance Services in Puerto Rico.

The Public Service Commission hereby notifies all the concessionaries, agencies and public corporations and political subdivisions of the Commonwealth of Puerto Rico and operators of the Public Service Commission authorized to the transportation of ambulance services and the public in general who are interested in submitting written comments to the aforementioned regulation can do so within thirty (30) days from the publication of this notice.

The purpose of this regulation is to regulate the ambulance services in Puerto Rico with or without pay and to establish the requirements for the expedition of authorization to any natural or juridical person, including agencies and public corporations and political subdivisions of the Commonwealth of Puerto Rico and its instrumentalities.

Any interested party may submit its written comments to the proposed amendments to the Regulation within thirty (30) days from the publication of this notice. The Commission will also conduct Public Hearing on this matter on Monday, August 8, 2006 at 8:30 a.m., at the Public Service Commission's central office, Hearing Room A. In order to participate in the public hearing the parties must submit a written request within thirty (30) days from the publication of this notice.
